## A.R.E. Homes Philosophy and structure

At A.R.E. Homes we believe that each client is unique and must be treated that way, however, certain aspects must be included in each individual's recovery. At A.R.E. Homes we help our clients find what will work for them by matching each client up with a recovery coach to help you figure out what successful recovery looks like while providing a sober environment for clients to transition back into the community. Each client will look at certain areas in their life with an assigned recovery coach, and choose what will work long term for their recovery. Area's include but are not limited to support, social life, finances, job/school, hobbies, exercise, overall health, spiritual/religious, giving back and healthy family structure. We believe we need to meet you where you are at, and help you find what recovery looks like to you.

Along with coaching, all residents must participate in the A.R.E. Homes community and must attend house meetings unless prior approval is given by staff. House meetings will be held Tuesday at 6:00pm and to be determined by availability of staff and residents (we will try to work with work schedules).

Because the whole family hits a bottom during their loved ones addiction, all families are highly encouraged to use the yearlong program, Be A Loving Mirror offered through Family Recovery Resources LLC to learn how to support, not enable, and how to heal as a family.

#### **Personal Items**

Upon arrival at A.R.E. Homes LLC, all property will be searched and approved. This is done to keep the residents and the community safe. Items that are inappropriate will be held in the safe, disposed of or donated to charity.

By signing below I also agree that any theft, loss, or damage of any kind to any personal property is not the responsibility of A.R.E. Homes LLC, and that I will not hold A.R.E. Homes LLC responsible. Items of personal or monetary value should not be brought to the facility.

## A.R.E. Homes LLCHome Rules and Guidelines:

- Racism, sexism, homophobia, or any comments, attitudes, and / or behaviors that are derogatory towards any group or individual are not acceptable in any context or circumstances at any time, and are grounds for expulsion.
- Any behavior that constitutes bullying as determined by the A.R.E. Homes LLC community is grounds for immediate expulsion.
- A.R.E. Homes LLC require a 1 month minimum commitment, this program is not a week-toweek living situation.
- All clients will not be able to leave A.R.E. Homes for the first 24 hours unless approved by staff.
- Clients will not be able to leave overnight unless approved by staff.
- Families will have access to family coaching provided by Family Recovery Solutions LLC.
- Clients must arrange their own transportation to A.R.E. Homes LLC.
- Vehicles will be permitted for residence with a valid driver's license and insurance.
- Proper personal hygiene is mandatory.
- Proper clothing must be worn at all times and will be determined by staff.
- No pornography of any kind.
- · No physical altercations.
- Noise levels will be kept to a reasonable level determined by staff.
- Be respectful of our neighbors.
- No smoking or vaping in the house.
- No instruments or loud music after 10:00pm.
- Refusal to complete any drug screening is cause for expulsion.
- Attend the house meetings Tuesdays and any others TBD.
- You must actively work with your assigned recovery coach and actively work to complete weekly assignments you set for yourself.
- Bed must be made by 10:00am on the weekdays, 11:00am on the weekend.
- Complete individually assigned chores at designated times.
- Room must be kept clean (no mess on floors).
- Opposite gender and children are only aloud in common areas until curfew.
- Any visitors may be asked to leave at any time for any reason.
- Residents are not allowed in other residents bedrooms without permission.
- Curfew is 10:30 p.m. Sunday through Thursday and 12:00 a.m. Friday and Saturday unless approved by staff.
- Community house electronics will be turned off by 12:00am (TV, computer, ect.).
- Groceries are not included, residents will be responsible for their own food and meals.
- Fees are \$795 per month (30 days) after the first month, payable before next months stay.
- Find a job and work 30 hours per week or actively search for employment, schooling or volunteer opportunities.
- Failure to fully disclose any prescription medication, or the use of any prescribed medication not in accordance with the stated directions for use is grounds for immediate expulsion.
- All personal items must be removed from the premises within 48 hours of completing your stay at A.R.E. Homes LLC.
- Follow any and all other rules made or updated by staff.
